MEMORANDUM OF UNDERSTANDING (MOU)

BETWEEN

PRINCESS OF NARADHIWAS UNIVERSITY (PNU) THAILAND

AND

INSTITUT AGAMA ISLAM NEGERI PONOROGO (IAIN PONOROGO) INDONESIA **THIS MEMORANDUM OF UNDERSTANDING** is made on **13**thday of December 2019;

BETWEEN

PRINCESS OF NARADHIWAS UNIVERSITY an institution of higher learning and having its address at 99 Moo.8 T. Khokian A. Muang, Narathiwat Province 96000, THAILAND (hereinafter referred to as "PNU") of the other part.

AND

INSTITUT AGAMA ISLAM NEGERI PONOROGO, a state Islamic institute which was Faculty of Shariah of IAIN SunanAmpelSurabaya East Java. Due to the decision of President of Republic of Indonesia number 11, 1997 on establishing state Islamic institute, the Faculty separated from IAIN SunanAmpel and, independently, became Islamic State of Ponorogo for Islamic Studies and having its correspondence address at JalanPramuka 156, Ponogorogo, East Java, 64371, Indonesia(hereinafter referred to as "IAIN Ponorogo") and will include its lawful representatives and permitted assigns on the other part;

PNU and **IAIN Ponorogo** shall hereinafter be referred to singularly as "the Party" and collectively as "the Parties".

WHEREAS:-

- A. PNU is a government sponsored university in Narathiwat, southern Thailand. It was founded under the act on 9 February 2005 by merging all educational institutions in the province. Those institutions are Narathiwat Technical College, Narathiwat Agricultural & Technology College, Takbai vocational college and Boromarjonani College of Nursing, Narathiwat. Princess of Naradhiwas University provide vocational and high vocational knowledge and expertise to students, as well as to develop human resources and cultural resources to be of the greatest benefits to the society and the nation.
- B. IAIN Ponorogo is an established institute in East Java that concerned to the community development especially in education and consistently pursue innovation in a framework to realize the mission of bulding an Islamic scholar society.

C. The Parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties upon the terms as contained herein.

THE PARTIES HAVE REACHED AN UNDERSTANDING as follows:

ARTICLE I

OBJECTIVE

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from time to time in force in each Party's country, will endeavour to strengthen, promote and develop on a basis of direct cooperation and collaboration in the field of research, education and in training programs on the basis of equality and mutual benefit.

ARTICLE II

AREAS OF COOPERATION

- 1. Each Party will, subject to the laws, rules, regulation and national policies from time to time in force, governing the subject matter in their respective countries, endeavour to take necessary steps to encourage and promote cooperation in the following areas:
 - a) Exchange of Staff and Students
 - b) Joint workshops and training programmes
 - c) Joint research and development projects
 - d) Joint education programs
 - e) Collaboration in Publication
 - f) Cooperation in Other Areas

2. For the purpose of implementing the co-operation in respect of any area stated in paragraph 1 above, the Parties will enter into a legally binding agreement subject to terms and conditions as mutually agreed upon by the Parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of dispute".

ARTICLE III

FINANCIAL ARRANGEMENTS

- This Memorandum of Understanding will not give rise to any financial obligation by one Party to the other.
- Each Party shall bear its own cost and expenses in relation to this Memorandum of Understanding.

ARTICLE IV

EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not deemed to constitute or create any legally binding or enforceable obligations, express or implied.

ARTICLE V

NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either Party as the agent of the other.

ARTICLE VI

ENTRY INTO EFFECT AND DURATION

- 1. This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of **Five (5)** year.
- 2. This Memorandum of Understanding may be extended for a further period as may be agreed in writing by the Parties.

ARTICLE VII

NOTICES

Any communication under this Memorandum of Understanding will be in writing in the English language and delivered personally or sent by registered mail to the address or sent to the electronic mail address or facsimile number of **PNU**or **IAIN Ponorogo**, as the case may be, shown below or to such other address or electronic mail address or facsimile number as either Party may have notified the sender and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:
